Walter Long welcomed everyone and called the meeting to order at 5:31 p.m.

Walter Long asked the board to review the June 27, 2024 minutes. Steve Rice made a motion to approve the minutes, Miguel Troncoso seconded the motion. Motion passed by unanimous vote.

Kyle Karfonta stated the FY'23 audit is coming to conclusion, the auditors came out to test Medicaid revenue and review awards, everything seems to be going well, feedback has been positive. The audit should be finalized by the end of September. The FY'24 audit will begin in October. Hopefully by the October meeting we will have the formal audit report. Although, due to the audit we do not have financial reports at this time.

Heather Helberg presented the FY'25 Fixed Rate Contract Amendment - Criminal Justice - Veterans Court Treatment - State with the amended amount being \$55,000.00. HOPE has been asked by the Department of Mental Health to participate in Veterans Court, which has roughly 15-25 clients. Mrs. Helberg also presented the FY'25 Sole Source Contract Amendment - Flex Funds - Housing - State with the amended amount being \$1,200.00, HOPE has been spending well and was awarded more funds. Miguel Troncoso made a motion to approve the FY'25 Contract Amendments, Sherry Read seconded the motion. Motion passed by unanimous vote.

Heather Helberg stated the sale of 4720 South Shields Boulevard has been completed. We listed the property on a Friday and by Monday we had four offers. The final offer was \$20,000 above the asking

price. We have moved the transportation and maintenance teams to the 6100 S. Walker location and plan to use the funds from the sale to build a new bus barn and maintenance office. Miguel Troncoso attending the closing with Mrs. Helberg. The new owners will turn the property into a car lot and a mechanic shop.

Heather Helberg presented the Section 3.11.01 Paid Time Off Policy and Procedure update, which now has HOPE's Wellness Days policy that gives every employee, excluding URC staff, one Friday off every month. Mrs. Helberg also presented the Section 3.27.04 Office Furniture Policy and Procedure update, which states employees should not bring in personal furniture but if an item is needed to enhance their workspace it will need to be reviewed by the Chief Clinical Director. Steve Rice made a motion to approve the Section 3 Policy and Procedure updates, Andrea Grayson seconded the motion. Motion passed unanimously.

Heather Helberg presented changing the Board of Directors meeting schedule for 2025; to not overload the meetings and requiring the assistance of the different committees in between meetings, we are requesting six meetings a year, January, March, May, July, September, and November. This will be voted on at the October Board of Directors meeting.

Miguel Troncoso presented three responses to HOPE's Family URC RFP bids: DIAK Architects, RAD Collaborative, and Redland Childers Architects. Mr. Troncoso would like the Board to move forward with interviewing and requesting a fee schedule. The interviewers would need to decide how to go about the interview process and who would want to be included. Mr. Troncoso has worked with the three before and has a good relationship with them. HOPE plans to do some fundraising to help with the cost of the project. Sherry Read made a motion to move forward with the interviewing process, Earlene Bieger seconded the motion. Motion passed by unanimous vote.

Heather Helberg reviewed the CEO report. Melanie Johnson and Mrs. Helberg went to Nashville to look at the behavioral health center at their jail. They will help create policy and procedures. HOPE was approached by Healthy Minds and asked to speak with other non-profit organizations about being a CCBHC.

HOPE was quoted in the report from National Council, the President of the Council emailed Mrs. Helberg, they had a meeting, this may lead to some media exposure for HOPE.

We are still waiting to hear about the BISS Mid-Del contract, and the ARPA projects, they've started awarding ARPA contracts in District One, but we are in District Two. We are also awaiting notifications from Inasmuch, Everyone Deserves Access, US Probation for treatment services for aftercare after prison, and the OKC Community Foundation for Aging Services.

HOPE was asked by the Department of Mental Health to expand our mobile crisis in OK county, we may need to add some staff to accommodate.

Great Plains accounting software will be in end of life in 2028. We should start looking now for new software. We've consulted with Eide Bailly, we wouldn't make the switch until FY'26.

Variety Care and Northcare have merged, they've sold their portion of HOPE Pharmacy to Virgil Todd, we are now 50/50 owners with Mr. Todd. We will need our Board Members to complete some trainings for the Pharmacy as well as providing information to run background checks.

Proceeds from the sale of the Shields property will go towards building a bus barn and maintenance office behind the 6100 S. Walker property. Mr. Troncoso will help with this process.

4.20.00 COMMITMENTS, CONTINGENCIES, AND COMPLIANCE POLICY (403(B)

This policy outlines the process for identifying, evaluating, and accounting for commitments, contingencies, and potential litigation. It ensures compliance with applicable laws and regulations and facilitates accurate reporting and disclosures related to claims and loss contingencies.

This policy applies to management and relevant staff responsible for monitoring compliance with legal obligations, overseeing litigation, and addressing claims that could impact the organization financially or reputationally.

POLICY FOR IDENTIFYING COMMITMENTS AND CONTINGENCIES

The CHRO and CFO, in collaboration with outside legal counsel when necessary, regularly review the company's activities to identify potential commitments and contingencies that could lead to claims or legal action.

Periodic inquiries are made with key stakeholders to ensure that all potential legal risks, claims, or obligations are identified.

EVALUATION PROCESS FOR LITIGATION, CLAIMS, AND LOSS CONTINGENCIES

Once a potential litigation or claim is identified, CHRO and CFO assesses the nature, likelihood, and impact of the claim seeking legal consultation when warranted.

Claims are categorized based on severity (low, moderate, high) and likelihood (remote, possible, probable). This evaluation includes determining the financial impact and potential disclosure requirements.

A record of all litigation, claims, and loss contingencies is maintained, with documentation of assessments and decisions related to each case.

COMPLIANCE WITH LAWS AND REGULATIONS

The organization regularly reviews applicable local, state, and federal laws to ensure ongoing compliance. Changes to laws or regulations are promptly addressed through updates to internal policies and staff training.

Internal audits and reviews are conducted annually to verify that all compliance-related procedures are being followed, and new or updated regulations are implemented effectively.

Staff involved in compliance, legal, and financial reporting receive ongoing training to stay updated on relevant laws and best practices for reporting and managing claims and contingencies.

ACCOUNTING AND REPORTING PROCESS

If a loss contingency is deemed probable and can be reasonably estimated, the financial team records the liability in the financial statements in accordance with generally accepted accounting principles

For all significant legal claims or contingencies, appropriate disclosures are made in the financial statements in order to provide transparency to stakeholders.

Litigation and claims are monitored throughout the year, with updates provided to the financial team to ensure accurate reporting in interim and annual financial statements.
